AYRA NEW RULES FOR PAYMENT AND REGISTERING FOR THE 2024-2025 RODEO SEASON

- 1. ALL MEMBERSHIPS AND SPONORSHIPS ARE DUE NO LATER THAN THE MEMBERS FIRST RODEO. Please mail in all membership packets and membership payment prior to the rodeo so all back numbers can be finished.
- SINGLE MEMBERSHIP AND SPONORSHIP IS \$100
- FAMILY MEMBERSHIP AND SPONSORSHIP IS \$150 (\$25 PER ADDITIONAL CHILD AFTER INITIAL 4 CHILDREN)
- 2. ALL PARTICIPANTS MUST BE REGISTERED AND PAID IN FULL BY THE WEDNESDAY BEFORE THE RODEO. (1 EXCEPTION NEW MEMBERS WHO MAY NOT KNOW THE RULE) ANYONE NOT PAID WILL NOT BE ALLOWED TO RIDE.

Must ride in the Saturday Final in June with at least one covered ride with points for the season and the top 10 returning on Sunday.

12 & UNDER:

Must compete in at least 8 rodeos in the same event before the June finals.

Must be a member in good standings. (All fees paid)

Must ride in the Saturday Final in June with the top 10 returning on Sunday.

13 & OVER:

Must compete in at least 8 rodeos in the same event before the June finals.

Must be a member in good standings. (All fees paid)

Must ride in the Saturday Final in June with the top 10 returning on Sunday.
